CHAIR'S REPORT

2017 has been an important year for Near Neighbours. It has seen us extend the reach of our work across the country with a new hub in East Lancashire and at the same time develop a whole new programme called **Real People**, **Honest Talk** which encourages people to talk about the issues and concerns they have about living together in particular neighbourhoods.

We have developed an extensive network of communities and individuals who want to see better levels of joint working and are prepared to face the challenges created by such an aspiration. When this is combined with our small grants work, which enables local communities themselves to address integration, and the work we do with faith leaders and young people then we have a very effective tool for addressing the fragmentation and separation which blights our common life.

The publication in 2018 of the Integrated Communities Strategy green paper will provide an important focus for our work in the future. Much of our work over the last six years has been about confronting the segregation that can divide communities and we want to develop a good working relationship with MHCLG as they implement the activity which will lead to real change in this issue.

Our trustees and staff team are our key assets in this work and my thanks to them for their commitment and vision.

REPORT OF THE TRUSTEES FOR THE YEAR ENDED 31 DECEMBER 2017

The trustees present their annual report and financials statements of the charity for the year ended 31 December 2017. The financial statements have been prepared in accordance with the accounting policies set out in Note 1 to the accounts and comply with the Memorandum & Articles of Association, the Companies Act 2006 and Charities Act 2011, and Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland published on 16 July 2014.

TRUSTEES' REPORT AND FINANCIAL STATEMENT FOR THE YEAR ENDED 2017



OBJECTIVES AND ACTIVITIES

Near Neighbours was created by CUF and the Archbishops' Council of the Church of England following the award of £5m by the Ministry of Housing, Communities and Local Government (MHCLG – formerly DCLG) in February 2011. Since then, further grants have been given and the programme is currently funded until March 2020, principally by MHCLG.

The Near Neighbours (NN) programme works to bring people together who are neighbours in communities that are religiously and ethnically diverse, so that they can get to know each other better, build relationships of trust and collaborate together on initiatives that improve the local community they live in.

The charity aims to strengthen personal relationships and at the same time strengthen civil society. To create a more cohesive society where people live together respecting the differences they have with others and building a flourishing life together. The charity also encourages people to connect with each other across religious and ethnic divides through practical action, to improve their neighbourhood.

Main objectives:

- Social Interaction by building up personal relationships of trust so that people understand each other better. We work with people of all faiths and none with the aim to develop positive relationships that provide a foundation for people to work together.
- Social Action by building up civil society
 across divides of faith and ethnicity. We provide
 the opportunity for people to come together
 and work on creating positive change in their
 neighbourhood.

There are currently four main strands to the Near Neighbours work:

- Near Neighbours Hubs and Partners: Building diverse and resilient relational networks amongst faith and community groups across different faiths and ethnic backgrounds, and equipping leaders for effective collaboration and community engagement.
- Near Neighbours Small Grants: Bringing people together to develop, lead and participate in local projects that involve people of different faiths and ethnicities.
- Catalyst: A leadership programme, training young people from diverse backgrounds to be leaders and influencers in a multi-ethnic, multifaith society and in their local communities.
- Real People, Honest Talk: Creating safe spaces to address difficult local issues relating to diversity, through facilitated community-based conversations.

REVIEW OF 2017

The Near Neighbours programme has now been working in local communities bringing people from different ethnicities and social groups together since 2011 and was awarded funding of £1.65m from Ministry of Housing, Communities and Local Government (MHCLG) for the programme through to March 2018.

BEYOND THE STREETS, EAST LONDON

Beyond the Streets works to end sexual exploitation in the UK. It received a grant for a series of alternative Jack the Ripper tours around East London, which told the stories of the murdered women and explored why they had to sell sex for survival. This linked into modern awareness of sexual exploitation in Tower Hamlets, and involved discussions about how participants could work to address this issue.

LEA ROAD COMMUNITY CHURCH, WOLVERHAMPTON

In Wolverhampton, there were a lot of people moving into an area, staying for a short time, and leaving lots of rubbish in their houses and gardens. The local church applied for funding to hire a skip, so that residents, including Eastern Europeans and Asians, could come together to clean up the area and spread awareness about fly-tipping and proper waste disposal. There was also a neighbourhood Christmas party a few weeks after the clean-up, to further deepen friendships.

ST CHAD'S SANCTUARY, BIRMINGHAM

In Birmingham, St Chad's Sanctuary supports local asylum seekers and refugees. Working in partnership with the Birmingham Opera Company, it ran English through Song, which were singing sessions for local asylum seekers and refugees, that culminated in two public performances. After the project, participants could join the Company's community chorus, so they can meet more local people and develop friendships.

GAYDIO. MANCHESTER

Gaydio is an LGBT radio station based in Manchester. It received a grant for local people in Longsight to come together and learn more about radio production, by creating shows about issues faced by LGBT people of faith.

SPEAK STREET, NORTH LONDON

Speak Street provides English language classes to local refugees, asylum seekers, and migrants. It worked in partnership with a community garden in King's Cross to run cooking and gardening projects for its beneficiaries, with volunteers coming from the local church. A community cook book was also created to document the project and celebrate the achievements of participants.



In 2017 we were able to start a new hub in East Lancashire (expanding from previous work in Burnley) into Hyndburn, Pendle and Blackburn and Darwen, and expand the Greater Manchester work from Oldham, Bury and Rochdale into Manchester itself.

We began a new initiative called **REAL PEOPLE, HONEST TALK**, in Luton and in the Black Country, bringing local people together in neighbourhoods to discuss issues that mattered in their local areas. About 280 people took part in these. These two pilots will inform our work in the coming years and we hope to take this programme to other areas following a successful evaluation by Leeds University.

We were able to expand our **CATALYST** young leaders programme and had a number of programmes in 2017. In 2017, 161 young people took part in a Catalyst programme. 54 of these were prior to the new Catalyst team joining in June, and 106 were after. 13 Catalyst programmes in total were run in 2017, making the average participant number per programme 12. Courses were run in Bradford, Leeds, Manchester, Rochdale, Luton, Nottingham, Black Country, Leicester, and London.

As part of the programme in 2017, Near Neighbours invested £1.2m in grassroots activity, giving grants to a total of 393 community projects, with an average grant size of £3k. In 2017, projects funded by Near Neighbours engaged over 76,000 people in local communities across the nine Hubs. After completing their grant-funded activities, 92% of project leads reported feeling better equipped to take action and change things in the community.

FUTURE PLANS

2018 will see us continue this work of building relationships between different ethnic and religious groups, to encourage greater levels of participation in this activity and to develop the skills and experience of those we work with.

We plan to expand our work of local conversations - Real People, Honest Talk. We also plan to raise funds to support the expansion of our Catalyst leadership programme.

We will be working with local authorities where there is a priority of work on Integration through the Integration Strategy of MHCLG.

We are supporting the expansion of **PLACES OF WELCOME**, an initiative which creates a weekly place where people can meet for refreshment, conversation, signposting to local support and the offer to participate in activities.

A new website will signpost people to where they can find a local Place of Welcome and how to set one up.

DELIVERING PUBLIC BENEFIT

Near Neighbours brings people together in diverse communities, helping them to build relationships and collaborate to improve the local community in which they live.

Near Neighbours also financially supports and works with a wide range of community and faith organisations, all of which are working to bring communities together.

The trustees have reviewed the guidance on public benefit issued by the Charity Commission and consider that Near Neighbours' aims and activities, as set out above, fulfill the criteria. The trustees do not anticipate any change in the future to this operational approach. The trustees consider the guidance on public benefit each year.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing Documents

Near Neighbours is both a company limited by guarantee (Registration Number 07603317) subject to the Companies Act 2006 and a charity registered with the Charity Commission (Charity Number 1142426).

It is governed by its Memorandum and Articles of Association dated March 2011.

Governance Structure

The directors of the company are known as trustees. The Articles of Association allow for up to thirteen trustees, six being nominated by the Archbishops' Council and seven by CUF. The trustees meet four times a year to review strategy, operational and financial performance. The trustees are listed on page 3 of this report.

None of the trustees receive any remuneration or benefits from Near Neighbours. Any expenses reclaimed are set out in note 5 to the financial statements.

Trustee Induction and Training

All trustees on appointment receive a detailed briefing on the Memorandum & Articles of Association, the objectives of the programme and the agreements with CUF, the MHCLG and delivery partners.

Trustees also have the opportunity to visit projects and are kept abreast of developments at each board meeting through a detailed progress report by the Programme Director and a cycle of presentations by partners.

Management and Organisational Structure

The day-to-day management and delivery of the Near Neighbours programme is delegated to the Executive Director of CUF and Programme Director who is managed by the Executive Director; the Programme Director works closely with other members of CUF's staff. Formal reporting by the Programme Director to the Board takes place regularly throughout the year.



Principal Risks

The Trustees have a risk management strategy that ensures that they actively review the potential risks and uncertainties that may seriously affect the charity. A central risk register is held to ensure that all areas of the charity are assessed for risks and suitable policies and procedures are put in place to mitigate those risks.

The trustees have considered the key potential risks facing the Near Neighbours programme and how they are managed which are outlined below:

Key Management Personnel Remuneration

The trustees consider the board of trustees, the Executive Director, the Programme Director and Project Director as comprising the key management personnel of the charity in charge of directing and controlling the charity and running and operating the charity on a daily basis.

The salary of the Programme Director is reviewed annually and normally increased in accordance with inflation. In view of the nature of the charity, the trustees benchmark against pay awards in similar charitable organisations. The trustees of CUF set the salary of the Executive Director as the role is shared between several charities, following a similar process.

Small Company Exemption

The company has taken advantage of the small company exemption as it is within the threshold criteria. The accounts have been prepared in accordance with the special provision contained in the Companies Act.

FINANCIAL REVIEW

Income

Overall income for the year to 31st December 2017 was £2.11m (2016: £1.89m). All income was restricted

to the Near Neighbours programme and relates to funding primarily from the MHCLG and CUF.

Expenditure

The total expenditure on the three charitable activities was £2.18m (2016: £1.72m). The charitable activities together with their associated expenditure for the period are:

Building Networks: £479k (2016: £432k) this
expenditure principally reflects the grants to
extend the capacity of the Local Presence and
Engagement centres set out in notes 3 and 6 to the
accounts.

Building Capacity by these three activities:

• Faith Leaders: £133k (2016: £117k)

Young Leaders: £202k (2016: £142k)

Communities: £101k (2016: £152k)

This expenditure principally reflects the grants to our partners set out in notes 3 and 6.

 Creating Engagement: £1.26m (2016: £877) represents Near Neighbours small grant fund, as set out in note 4 to the accounts.

Reserves and Reserves Policy

All reserves are treated as restricted and any reserves held at the year end represent funds set aside for future programmes. There was a £104k balance in reserves at 31st December 2017 (2016: £173k).

THE TRUSTEES' RESPONSIBILITY

FOR PREPARING ANNUAL FINANCIAL STATEMENTS



The law applicable to charities in England and Wales requires the trustees to prepare annual financial statements for each financial year that give a true and fair view of the Charity's financial activities during the year, its surplus or deficit for the year and its financial position at the end of that year.

In preparing annual financial statements, the trustees have followed best practice and:

- Selected suitable accounting policies and applied them consistently
- Made judgments and estimates that are reasonable and prudent
- Followed applicable Accounting Standards and Statements of Recommended Practice
- Prepared the annual financial statements on the going concern basis.

The trustees are responsible for keeping proper accounting records that disclose with reasonable accuracy at any time the financial position of the Charity and enable them to ensure that the accounts comply with the Companies Act 2006. They are also responsible for safeguarding the Charity's assets and for taking reasonable steps to prevent and detect fraud and other irregularities. The trustees have overall responsibility for ensuring that the Charity has appropriate systems of control, financial and otherwise.

Each of the trustees at the date of approval of this report confirms that:

- So far as the trustees are aware, there is no relevant audit information of which the Charity's auditors are
- The trustees have taken all the steps that they ought to have taken as trustees to make themselves aware of any relevant audit information and to establish that the Charity's auditors are aware of that information.

The trustees reappointed Mazars LLP as auditors at the Board Meeting on 26th April 2018.

OPINION

We have audited the financial statements of Near Neighbours (the 'charity') for the year ended 31 December 2017 which comprise the Statement of Financial Activities, the Balance Sheet, the Statement of Cash Flows and notes to the financial statements, including a summary of significant accounting policies. 1. ACCOUNTING POLICIES

a. Basis of accounting

The accounts (financial statements) have been prepared under the historical cost convention with items recognised at cost or transaction value unless otherwise stated in the relevant notes(s) to these accounts.

The financial statements have been prepared in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) issued on 16 July 2014 (effective 1 January 2014) and the Companies Act 2006. The charity constitutes a public benefit entity as defined by FRS102.

The Trustees consider that it is appropriate to prepare the accounts on a going concern basis and believe that there are no material uncertainties about the organisation's ability to continue as a going concern.

Church Urban Fund is committed to support Near Neighbours programme in the event that no further funding from MHCLG is obtained and will provide financial support in the short term to ensure that it continues as a going concern.

b. Income recognition

Church Urban Fund receives funds from the Ministry of Housing, Communities and Local Government (MHCLG) which is then passed to Near Neighbours and used to administer the programme in accordance with the agreement between Church Urban Fund and Near Neighbours.

Additionally, Church Urban Fund contributed some of its own funds to support Near Neighbours and all income is recognised when it is received.

c. Support costs

Support costs comprise of costs relating to statutory audit and legal fees together with an apportionment of general overheads. Support costs relating to charitable activities have been apportioned based on staff time spent on each activity as analysed in note 8.

In addition to the costs incurred directly in the course of each charitable activity, Near Neighbours also incurs support costs that are necessary to enable it to carry out its activities. These costs are apportioned to activities based on the time spent on each.

d. Charitable activities

The costs of charitable activities include grants made, governance costs and an apportionment of support costs as shown in note 3.

e. Grants

Delivery Partners submit quarterly returns against budget before they are paid future funding as unspent amounts in one year would result in a reduction of grant in the next. The grants are charged to the Statement of Financial Activities once funds have been transferred to the recipient's account. Payments are made on behalf of Partners where there is an absence of a operational bank account due to a delay in the setting up of the account.

The grant to Church Urban Fund to administer and make awards under the Small Grants Programme is charged to the Statement of Financial Activities once the funds have been committed.

f. Pensions costs

The charity operates a defined contribution pension scheme, Church Urban Fund Pension Plan with Legal and General. The pension charge represents the amount payable by the charity to the scheme in respect of the year to which they relate and are included within staff costs (note 5).

g. Fund accounting

Restricted funds are funds subject to the specific restrictive conditions imposed by donors.

12. RELATED PARTY TRANSACTIONS

During the year, Near Neighbours entered into the following transactions with its parent company CUF:

CUF received the full amount of grant from MHCLG of £2m (2016: £1.7m) and passed this over to Near Neighbours to deliver the programme.

At the year end, there was £134k intercompany balance owed by CUF (2016: £167k).

All of these grants were made at arms length and in the normal course of the charity's business in pursuit of its charitable objectives.

Reverend Mark Poulson, is a Trustee of both Near Neighbours and The Kings Centre Southall, which received grants of £40k during the year.


The Right Reverend Michael Ipgrave is a Trustee of both Near Neighbours and The Council of Christians and Jews, which received grants of £11k during the year.
